**EXTREME HIGH WATER - When the Carrolton gauge reaches 12' (Extreme High Water) an additional surcharge will be added to all In/Out charges for all LMR fleets, which is a result of the additional HP requirements as mandated by the USCG in 33 CFR § 165.803. **Extreme High Water Surcharge
