High Water Designations

In West Virginia, High Water fleeting rates will go into effect when the South Side Bridge on the Kanawha River water level reaches 11'.

HIGH WATER - When the Baton Rouge gauge reaches 28' (High Water status) there will be a **33 1/3%** surcharge on all rates on the LMR due to a reduction of tow sizes and fleeting capacity as per the Mississippi River Crisis Action Plan.

****EXTREME HIGH WATER** - When the Carrollton gauge reaches 12' (Extreme High Water) an **additional surcharge** will be added to all In/Out charges for all LMR fleets, which is a result of the additional HP requirements as mandated by the USCG in 33 CFR § 165.803.

This fuel escalator applies to all rates that do not have negotiated fuel escalation clauses.
Rate Sheets will indicate if there is a negotiated fuel escalation.

Fuel will be escalated monthly using \$2.00 as the base price.

Price will be established by the average price of fuel from the prior month.

Price will be set using Platts Oilgram Price Report, Product Price Assessments, U.S. Gulf Coast, Waterborne Low, Ultra Low Sulfur Diesel.
